1. The Document containing detailed terms & conditions for Auction can be downloaded online from website "[www.mprdc.nic.in](http://www.mprdc.nic.in)" on free of cost. The deadline for physical submission of offers is 22.01.2016 upto 03:00 PM and the same shall be opened at 03:30 PM on the same day. The Addendum/Corrigendum (if any) shall only be published on the website of [www.mprdc.nic.in](http://www.mprdc.nic.in) only.
2. The Officers/Employees of MPRDC or their relatives should not be allowed to participate in the Auction process as Bidder.
3. Each bidder shall submit only one offer. A bidder who submits more than one offer will be liable for rejection of both the offers.
4. The Bidder has to submit the following documents along with the bid/offer in separate envelopes:

#### A. Envelope A

- i. PAN Card and Latest income Tax Return.

- ii. Power of Attorney
- iii. The bidder has to submit a Caution Money Deposit (EMD) of Rs. 5,000/- by way of Demand Draft in favour of Managing Director, M.P.Road Development Corporation Ltd. Payable at Bhopal,

- 5. The Estimated Value (upset Price) as fixed by the Seller for this Auction is **Rs. 43,600. 00 (Rupees forty three thousand six hundred only)**. It may be noted that the bidder is to pay sales tax, service tax if any, in the name of the Seller as per prevailing rate as applicable in excess of his offer price. All the relevant taxes, levies, duties, etc. which be required for removing these items from the Seller's premises shall also be payable by the bidder as extra.
- 6. The bidders are advised to visit and examine the site where the items are lying and its surroundings and obtain all information for itself on its own responsibility that may be necessary for preparing the offer and removing the items from the site to their own captivity, in case their offer becomes successful. The costs of visiting the site shall be at the bidder's own expense.
- 7. The offer shall remain valid for a period of 90 days after the deadline date for offer submission. The seller shall reject a offer valid for a shorter period.
- 8. Bidder shall submit offers that fully comply with the requirement of this document. Conditional offer or alternate offer will not be considered and will be summarily rejected.
- 9. Prior to expiry of the offer validity, the Seller will notify the successful bidder by e- mail/fax and by letter that his offer has been accepted. This letter hereinafter called the "Letter of Acceptance" shall name the sum which the successful bidder will pay the Seller for taking delivery of the Items according to the conditions laid in this document. The Caution money deposit of the unsuccessful bidders will be returned without any interest as promptly as possible but not later than 30 days after

the expiry of the period of offer validity. The Caution Money deposit of the successful bidder may be forfeited:

- a. If the bidder withdraws his offer during the period of offer validity.
  - b. If the bidder does not accept the correction of his offer price.
  - c. If the bidder fails within the specified time limit to deposit the balance amount of his offer amount.
10. Where there is a discrepancy between the offer price in figures and in words, the offer price in words will govern.
  11. The Seller reserves the right to accept or reject any offer, and to cancel the process and reject all offers, at any time prior to the issuance of letter of acceptance, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the Seller's action.
  12. Within 3 (three) working days from the date of issue of letter of acceptance by the Seller, the successful bidder should deposit the balance offered amount, after deducting the caution money deposit, in the form of crossed demand draft in favour of "The Managing Director, M.P. Road Development Corporation Ltd.," Payable at Bhopal failing which the caution money deposit will be forfeited.
  13. After depositing the balance amount as stated hereinabove, the Seller will issue "**Sale Letter**" to the successful bidder.
  14. The Successful bidder should remove these items from the Seller's Premises within 10 (Ten) days from the date of issue of "Sale Letter". In case the items are not removed after 10 days from the date of "Sale Letter", demurrage will be charged at the rate of Rs.200/- per day.
  15. In case the successful bidder fails to remove these items from the Seller's premises within 15 day's time period from the date of issue of Sale Letter, the entire offer amount deposited by the bidder will be forfeited and these items will be re-listed for sale at the risk and cost of the bidder.
  16. The items shall lie at the sole risk and responsibility of the bidder in all respects from the date of issuance of notice to proceed and must be taken away by the bidder at his own expense. All the relevant taxes, levies, duties, etc. which may be required for removing these items from the seller's premises shall be payable by the bidder as extra and no financial impact should lie on the seller on this ground.
  17. Should the original bidder wish to take the delivery of the goods through his representative (anybody else from the person signing the offer), he must authorize his representative through a letter of authority which shall be presented to seller.
