- Pay a non-refundable fee of INR 50,000/- (Rupees fifty thousand only) or USD 850 (US Dollars Eight Hundred Fifty only) **per Civil work Package** in the form of demand draft in favor of Managing Director, Madhya Pradesh Road Development Corporation Limited payable at any Scheduled Bank in Bhopal, Madhya Pradesh, India. If the Bidding Document is desired by courier/post, an additional sum of INR 1,000/- for the dispatch of the Bidding Document anywhere in India or USD 100 for overseas delivery. The employer shall promptly dispatch the Document by Courier/Post, but under no circumstances will it be held responsible for late delivery or loss of documents so mailed. **The Document shall be available for sale during office hours (IST 1030 hrs. to IST 1730 hrs.) from 03rd October 2018 to 19th November 2018.**

In case, the bidder submits the downloaded document, it should be accompanied with a Demand Draft of INR 50,000/- (Rupees fifty thousand only) or USD 850 (US Dollars Eight Hundred Fifty only) in favor of Managing Director, Madhya Pradesh Road Development Corporation Limited payable at any Scheduled Bank in Bhopal, Madhya Pradesh, India. **In case of any discrepancy between the documents downloaded by the prospective bidder and the Bidding Documents (hard copy) issued by MPRDC, the latter shall prevail.**
