## **Expression of Interest for short listing of Construction Supervision Consultants**

### **Title of proposed Project: Madhya Pradesh District Roads II Sector Project (MPDRIISP)- Consultancy Package-2 (Jabalpur)**

The Government of India has applied for a loan from the Asian Development Bank (ADB), and intends to utilize part of this loan towards the cost of the contract for consulting services related to Construction Supervision of Civil Works to be taken up under the proposed Project. Madhya Pradesh Road Development Corporation, a company fully owned by the Government of Madhya Pradesh and registered under the Companies Act, is designated as the Implementing Agency for the project.

Consultancy Service is for (i) Construction Supervision (ii) Monitoring and evaluating, using criteria of the project performance management system with focus on social impacts; and (iii) environmental management including monitoring of implementation of the mitigation measures to the adverse impacts to the environment, in accordance with ADB's Safeguard Policies. Three (3) Consultancy Packages for consulting services for construction supervision will be engaged namely Package - 1 (Bhopal), Package - 2 (Jabalpur) and Package - 3 (Rewa). A firm can apply for more than one Consultancy Package, but the firm will be awarded only one Consultancy Package. However this Expression of Interest is invited for Consultancy Package – 2 (Jabalpur) from eligible consulting firms of ADB member countries.

Package – 2 (Jabalpur) consists 9 Civil Work Contracts. This Package involves Widening and Reconstruction of about 658.60 Km of selected district roads in Madhya Pradesh. The input of International Experts is about 26 person months while the National Experts (including non key experts) is estimated to be 2202 person-months. The estimated cost is about US\$ 4.88 Million for this consultancy package.

The consultants are scheduled to be engaged for a period of 24 Months for Package-2 (Jabalpur) in line with the project implementation schedule. In addition to this, a partial input for 2 months is expected prior to the start of the civil works and after completion of work.

On the basis of the submission, the firms shall be shortlisted and invited to submit their proposals, in accordance with ADB's Guidelines on the Use of Consultants (the ADB Guidelines). The request for proposal to the shortlisted firms is expected to be issued in March, 2016. Selection of the consultant shall be done under QCBS (Quality and Cost Based Selection) (Full Technical Proposal) in accordance with the ADB Guidelines.

Simultaneous to this invitation, a Consulting Services Recruitment Notice (CSRN) is published on ADB's website for each package separately. The website includes a link to standard expression of interest (EOI) form that firms can download, filled out and submit online through ADB's website "www.adb.org".

For online submission: (1) register with ADB's CMS (Consultant Management System) at <http://www.adb.org/Consulting/cms.asp>, (2) go to <http://csr.adb.org>, (3) Click on "INDIA", (4) find the captioned project name and click on "view", (5) click on submit 'EOI' and (6) follow the instructions. All requested information must be filled in completely.
