ORDER

Government of India vide Notification S.O. 3407(E) dated 8th November, 2016 has declared that the specified bank notes i.e. the bank notes of existing series of denomination of the value of five hundred rupees and one thousand rupees shall cease to be legal tender with effect from the 9th November, 2016.

On account of shortage of lower denomination currency at toll booths, long queues were witnessed at toll booth of roads under BOT/OMT concession agreements. At many tollbooths law and order situation had been witnessed. On account of the above mentioned situation MPRDC vide it's order no.MPRDC/BOT/Toll/2016/12637dated 9/11/2016 had suspended toll collection on all toll booths under it's jurisdiction from the midnight of 8/11/2016 to the midnight of 11/11/2016 and further suspended the toll collection on all the toll booths from 11.00 AM of 12th Nov. 2016 to the mid night of 14th Nov. 2016 vide this office order No. 12806 dated 12.11.2016. The situation has not improved. Also, Government of India Ministry of Road Transport and Highways, New Delhi has further suspended the toll collection at toll plaza till the midnight of 25th December, 2016 in view of the difficulties being faced by the Highway users as well transporters. Therefore, in continuation of the office order No. MPRDC/BOT/Toll/2016/12637 dated 09.11.2016 and order No. order No. 13093 dated 18.11.2016, MPRDC further suspends toll collection activities at toll booths located on State Highways and MDRs under the jurisdiction

of MPRDC from mid night of 24th November 2016 to the mid night of 1st of December 2016. Concessionaires are directed to suspend the toll collection activities for the above period. The Toll collection will come in force w.e.f. 12.00 A.M. on 02.12.2016 as per the provisions of the Concession Agreement. The suspended period would be accounted for as per the provisions of the Concession Agreement.
