1. Delete the words “during last 5 years” from sub-clause 3(ii) (Responsiveness) of Expression of Interest. After deletion, the sub-clause 3(ii) shall read as follows: -

“(ii) The firm should have conducted One Hundred (100) statutory audit of the annual accounts of same company or different companies registered under Companies Act, 1956/2013 including any re-enactment or amendment thereof, of which at least ten should have been public sector undertakings or its branch.”

2. Replace the words “2nd April 2020 up to 11:30 hrs IST” from the sub-clause 7(ii) of the Expression of Interest with “the Bid Submission End Date and Time”.
3. Add the following at the end of sub-clause (iii) and (v) of clause 3 (Responsiveness) of EOI Document.

“The Paid Chartered Accountant and Partner both will be considered as Chartered Accountant on its role.”

4. The Document Download/Sale End Date, Bid Submission End Date, Bid Opening Date are hereby modified as follows: -

1. Document Download/Sale End Date	:	22 nd July 2020 11:30 AM
2. Bid Submission End Date	:	22 nd July 2020 11:30 AM
3. Bid Opening Date	:	22 nd July 2020 11:30 AM
