Sub:- Consultancy services for Authority's Engineer for supervision of Rehabilitation and Up-gradation of Jabalpur –Mandla-Chilpi section of NH-12A from km. 47/6 on NH-07 to Km. 12/6 on NH-12A upto km. 192/4 on NH-12A with Two lane with paved shoulder with provision of rigid pavement in the State of Madhya Pradesh on EPC mode under NHDP-IV on Engineering, procurement and construction (EPC) basis.

In continuation to this office Notice issued on account of deficiency in services under Clause 2.8 & 2.9 of Contract Agreement vide notice no. 22148/ Jabalpur-Mandla-Chilpi/ NH-12A/ AE/ 2015, dated 15.03.2018 and dissatisfactory performance of your Team Leader Mr. N.K.Garg notice under Clause 4.5(b) vide No.519/ Jabalpur-Mandla-Chilpi/ NH-12A/ AE/ 2015, dated 07.04.2018.

The Authority Engineer consultancy firm M/s Theme Engineering Services Pvt. Ltd. has not given any reply to show cause notice even after expiry of 30 days time. Authority Engineer has failed to show sufficient cause to the Authority within 7 days time.

The General Manager, MPRDC, Jabalpur vide letter No.2593/Gene./NH/MPRDC/ 2018 Jabalpur dated 20.03.2018 (a copy is already endorsed to you) has again informed about perpetual deficiency on the part of Authority's Engineer and has recommended to terminate the services.

The Authority therefore instructs to mobilize new Team Leader within 5 days time and show sufficient cause within 30 days time from the date of issue of this notice showing intention to terminate the Contract dated 24.08.2015 under Clause 2.9.1(a).


