In continuation to this office Notice issued on account of deficiency in services under Clause 2.8 & 2.9 of Contract Agreement vide letter no. 22148/ Jabalpur-Mandla-Chilpi/ NH-12A/ AE/ 2015, dated 15.03.2018. The Authority Engineer consultancy firm M/s Theme Engineering Services Pvt. Ltd. has not given any reply to show cause notice even after expiry of 20 days time. Authority Engineer has failed to show sufficient cause to the Authority within 7 days time.

Therefore, under Clause 4.5(b) of Contract Agreement dated 24.08.2015 it is directed to remove Mr. N.K. Garg, Team Leader of Authority's Engineer for above subjected project as his performance is dissatisfactory as he failed to perform his duties and there is gross negligence on his part.

The services of Mr. N.K. Garg, Team Leader of Authority's Engineer cease to be effective from issue of this order. Further Shri N.K.Garg, Team Leader is debarred for the period of for 3 years to participate in future tenders of consultancy services in MPRDC. The Consultant may submit CV of other suitable person for the position of Team Leader as per provision of Authority Engineer Agreement.
